Rachel Davies achieved First Place and the Watts Prize for the Audit & Assurance paper at the Professional Stage examination in June 2001.

This is how she did it...

Know which way of studying suits you - some people need to work at a slower pace over a longer period of time whereas some people are better at cramming last minute

Ensure that any hours spent studying are well spent. Two hours studying well are better than four hours "studying" of which two are spent looking out the window.

Prepare a study plan deciding upon which subject/chapter to study so that no time is wasted.

Do not be afraid to ask for help from your lecturers. That is what they are there for. Take proper breaks when you can. Distance yourself completely from studying for a while.

Finally, don't believe that my study regime is as organised as I make it sound!

'Calculating Your Future' – Insight into Professional Services

The ICAEW hosted a one-day event 'Calculating your future' at Chartered Accountants Hall in November. Now in its fourth year, the one day event is aimed at giving undergraduates an insight into a career in professional services. The firms taking part on the day were **BDO Stoy Hayward**, **KPMG**, **PfE**, **PwC** and **RSM Robson Rhodes** and **CRAC** (*Careers Research Advisory Centre*).



The workshop gave students the opportunity to:

- get a feel for the breadth of accountancy opportunities
- find out more about the ACA qualification – training and exams
- meet and work with representatives from a range of professional services firms and the ICAEW
- gain inside information on applications and interview techniques from graduate recruiters.

The workshop was filled with interactive activities throughout the day. Part of the session involved the students taking part in a fun icebreaker, where they were asked to design a team t-shirt that resembled various aspects of chartered accountancy.

The event was open to penultimate and final year undergraduates from a wide range of degree disciplines. It was publicised at universities and also on the websites of the participating firms and CRAC.



An overwhelming number of applications were received from students to attend the workshop, a selection process then took place to invite 60 students to London.



The feedback received from both students and firms has been extremely positive and many of the participating firms have expressed a very keen interest to take part again in 2003.

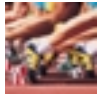

Professional Ethics Training - Objectivity

Carrying some extra weight after Christmas? (*And we're not referring to your waistline.*)
Objectivity, what is it? Let us consider a little fictional scenario...

In the summer you were introduced to a long-standing wealthy client of your employer. The client is renowned for his generosity. During a networking event you discover that you and the client have a mutual passion for whisky. It is a passion which you rarely get to indulge and the client jokes that one day you will earn enough to have the odd tippie without breaking the bank! Over the coming months you find that you have an excellent working relationship with the client and you are given more responsibility for their affairs.

On Christmas morning your partner produces a beautifully wrapped box, which had arrived a few weeks earlier and which your partner stored away for you. On opening it you discover a box of fine whisky from the client. (It must be worth £300.)



What are you thinking? That it wouldn't affect your objectivity? That if you keep quiet no one will know? Possibly. But why

has the client given you the gift? Will they read this as something which you should take into account in future when dealing with their affairs?



You should raise the question with your line manager. Find out your employer's policy on accepting gifts. Is there a limit on the value you can receive? Does the fact the sum is probably insignificant to the client have any bearing?

These are questions which you should address. So if there are any such issues weighing on your shoulders, perhaps one of your New Year resolutions (apart from quitting whisky!) should be to consider your objectivity and make sure you can maintain it.

Student Recruitment Team members become Young Enterprise Business Advisers

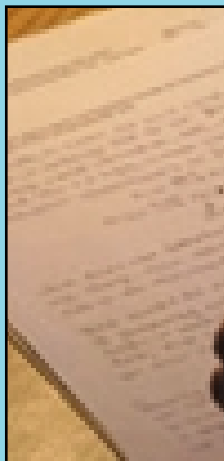

Qualified - What Then?

Those of you at latter stages of training contracts may already have your thoughts on the type of career you want on qualifying. The optimists will be relishing the host of different career paths available. The pessimists will be reflecting on how difficult the job market has become over the last 12 months!

Whichever camp you are in (and both views are correct) the approach to career planning is the same:

Self-assessment. Analyse your working life to date to start to assess where your abilities/interests lie.

For most, uncertain of the long term, consider the type of experience that will develop skills, provide the exposure to help in formulating objectives and maintain marketability.



Before making any move, consider (and hopefully talk frankly with) your present employer about what they can offer.

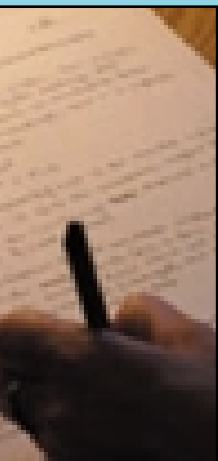
If you do decide on a job change, approach it as a self-marketing exercise: revisit and extend self-assessment; prepare a good CV; be able to present yourself well to employers and their brokers (ie recruitment agencies).

To get the “best” jobs on offer, these steps should always be adopted. When the job market is tight, as at present, they become even more important and different strategies may also need to be adopted if the type of opportunity you seek is just not available at present. Part of our role at the ‘Recently Qualified Career Service’ is advising members on just such issues.

Sitting exams out of a training contract and finding a new employer

Dear Lucy

I was employed for a year but after failing my Audit exam, my training contract was terminated. I am writing to find out whether or not it is possible to re-sit the paper on my own?

I am searching for a new employer but am eager to re-sit the exam at the next session, as I believe I won't fail at my next attempt. Can you let me know what my options are?



Lucy replies

You can sit the exam independently, as you are still a registered student of the Institute. You can have a break in service of up to two years. However, we advise that the Advanced Stage should be sat whilst in a

training contract and the case study cannot be taken until you have reached the final year of your training.

To help you in your search for a further training contract the Institute offers an Available Student Register for students whose contract is cancelled part way through their training. Ideally I would like to know what areas the Audit and Assurance paper covers and whether there are any books you could suggest that I read. Also where could I find a syllabus?

There is no recommended reading in terms of advance preparation for this course. However, we have an area on our website dedicated to students which can be accessed at: www.icaew.co.uk/students. You should find the Learning Resources section there very useful. There is a range of study related material, including past exam papers, marking keys, illustrative scripts and reports from the examiners. Syllabuses can also be found here and are useful if you wish to gain an overview of the content of any of the Professional Stage subjects.

When you arrive at your tuition centre for the first time you will be supplied with a full ICAEW study pack which supports your learning.

Don't feel isolated. Your tutors will provide you with access to other students who are at a similar stage in their training to yourself. Such contact will provide you with an excellent opportunity to develop mutual support mechanisms with your peers.
